The Town of Surf City has over 3200 sewer customers, 29 miles of 10" and 8" Gravity sewer lines, 29 miles of force main and 46 permitted lift stations in the collection system. The wastewater collected from the system is treated at the Surf City Treatment Plant located in Onslow County.

The Public Utilities Department is responsible for the daily operation and maintenance of the collection system. System maintenance includes cleaning and inspection of 10% of the system and weekly monitoring of the lift stations.

The Town of Surf City Collections Department had 1 non-reportable sewer spills from January through December 31, 2013. On January 5th, 2014, a 4 inch sewer force main was cut on the western end of highway 210 east. The force main was cut by an outside contractor's error. The sewer system for that area was immediately turned off and repairs were completed with-in 24 hours. Approximately 500 gallons of waste water escaped the main. The waste water was confined to the immediate area with no impact to the environment. After the local utilities were operational again, the surrounding areas were cleaned up and sanitized.
