The following guidelines are new and dynamic. In order to meet the needs of the community and maintain the facility and grounds, changes will be made as needed.

## **ARTICLE I: General usage**

- a. Individuals joining/visiting Surf City Community Center agree to follow all guidelines and posted rules.
- b. Individuals meeting any of the following criteria may join Surf City Community Center for a fee of \$12.00 per person per year:
  - Surf City property owners (tax payers)
  - Surf City business license holders (current)
- c. Individuals meeting any of the following criteria may join Surf City Community Center for a fee of \$25.00 per person per year:
  - Residential renters in the Town of Surf City who have their vehicles registered to their Surf City address (no PO Boxes, proof of residency required)
  - Employees of a Surf City Business (current pay stub required)
- d. Town of Surf City employees may join for a fee of \$0.00 per year, their immediate family members may join for a fee of \$12.00 per year.
- e. Active and retired Military may join for a fee of \$0.00 per year; Military Dependents may join for a fee of \$12.00 per year (Military Dependant ID required).
- f. Persons not meeting any of the aforementioned criteria may join Surf City Community Center for a fee of \$100.00 per person per year, additional \$50.00 for family member per year, not to exceed \$300.00 per family per year.
- g. Ages 65-74 – Half Price Full Membership (\$6.00 taxpayers, \$50.00 non-taxpayers)
- h. Ages 75 & Up – Free Membership
- i. Passes may also be purchased by non-members using the following fee scale:
  - Daily passes - \$5 per person
  - Weekly passes - \$20 per person
  - Monthly passes - \$30 per person
  
  - *Specific Activity/Class Pass* - \$25 per person per year for non-taxpayers
  - *Senior Exercise Pass* - \$25 per person per year for non-taxpayers aged 55+
- j. Individuals may choose to exchange volunteer hours with Surf City Parks & Recreation in lieu of monetary payment at an exchange rate of \$10 per hour based on the North Carolina average. Volunteer hours must be pre-approved and documented by Surf City Parks & Recreation and must be completed prior to membership approval.

- k. A scan of your driver's license/official ID is required for membership.
- l. Memberships are non-transferable and non-refundable.
- m. Membership includes:
  - Use of Exercise Room, Gymnasium (based on availability) and Tennis Courts
- n. Proof of identification and membership passes must be available at all times when on the premises.
- o. Children under 18 years of age must have their membership form signed by a parent or adult guardian prior to participation in any activity.
- p. **Children under 18 years of age must be directly supervised by a parent/adult guardian at all times, unless they are registered in AND actively participating in an official Parks & Recreation scheduled activity.**
- q. **Children under 18 years of age will not be allowed in the Exercise Room for any reason.**
- r. All persons will be expected to follow all rules and procedures. Noncompliance will result in loss of membership for an amount of time to be determined by the Director.
- s. All participants of Parks & Recreation sponsored activities must be members in full or in part or pay the visitor cost in order to participate (see Article I, sections a-f for more information).
- t. Activity schedules will be posted on the town website and on the information board at the Community Center.
- u. Willful destruction of Town of Surf City property will be fully compensated for by the individual or group involved.
- v. Patrons are expected to clean up after themselves and leave the building and grounds in good order for the next visitors.
- w. Only non-arts & crafts type activities may be held in the Conference Room and Community Room due to the floor surfacing.
- x. There may be no fire or flame in the building at any time for any reason.

## **Surf City Community Center Regulations**

**All users of the Surf City Community Center are asked to follow and practice common codes and principles of good citizenship and conduct. Please be respectful of the rights of others and treat the facility and grounds with respect.**

### **It is unlawful to engage in any of the following on town property:**

- Possess or consume alcohol or narcotic drugs
- Appear in a state of intoxication
- Aggressive behavior/fighting
- Refuse to comply with lawful order of the police or town official
- Beg, hawk, peddle or solicit
- Engage in gambling or gaming
- Use obscene, profane, abusive or offensive language
- Loiter in, around or in the vicinity
- Carry openly or concealed firearms or dangerous weapons of any kind
- Discharge a firearm or fireworks of any kind
- Remove or mutilate any vegetation
- Cause damage to buildings, signs, or other structures
- Litter or otherwise deposit any material
- Use tobacco in the facility or in the doorways of the facility.
- Write, paint, or carve on any tree, bench, or structure
- Kill, injure, harass, unnecessarily disturb, or feed any waterfowl or animals
- Cook or kindle any fire in any area not designated for that purpose
- Commit, perform, appear in a state of nudity, or engage in lewd, obscene or indecent acts or behavior
- Post or display any sign, banner, advertisement or notice of any sort
- Disturb the peace and good order
- Use amplified music and sounds
- Play loud music that disturbs recreation park or facility users
- Camp, sleep or park over night
- Drive motorized vehicles other than on roadways or parking areas
- Park in a roadway or block any entrance or loading/unloading zone
- Ride bikes, skateboards, skates or scooters other than on roadways or parking areas
- Break any Town Ordinance, regulation or law

### **Animal & Pet Regulations**

- NO pets are allowed inside facilities, service animals only.
- ALL pets must be confined to the immediate area of the owner AND on a leash not to exceed six (6) feet at ALL times as to not disturb or endanger other park users.
- Owners are required to clean up their animal litter/waste and dispose of it properly in a bag in park trash containers.

Other rules posted in the facility:

- Appropriate attire must be worn at all times
- No food, drinks or gum unless approved by Director
- Non-marring footwear only on community room floor

**When applying for Surf City Community Center Membership, options are as follows:**

For the \$12.00 rate (half price for 65-74), please provide one of the following:

- Current Surf City Tax Statement
- Current Business License for the Town of Surf City
- Current Military Dependent ID Card

For the \$25.00 rate (half price for 65-74), please provide one of the following:

- Current Vehicle Registration with Pender or Onslow as the County AND a Surf City Address on the registration card (NO PO BOXES)
- Current pay stub from a Licensed Surf City Business

Anyone that is unable to provide the above documents will need to pay using the following rates:

- \$100.00 for the 1st family member (half price for 65-74), \$50.00 for additional family members, \$300 maximum per family OR
- \$25.00 for a Specific Activity/Class Pass OR
- \$5.00 for a Daily Pass

Anyone age 75+ may become a member for free by completing a membership form and providing a current driver's license or official ID.

Active or retired military may become a member for free by completing a membership form and providing a veteran identification card or current military ID.

Individuals may choose to exchange volunteer hours with Surf City Parks & Recreation in lieu of monetary payment at an exchange rate of \$20 per hour based on the North Carolina average. Volunteer hours must be pre-approved and documented by Surf City Parks & Recreation and must be completed prior to membership approval.
