We routinely monitor for the presence of drinking water contaminants. Monitoring results for water collected during the time period ending December 31, 2013 show that our system exceeds the standards, or maximum contaminant level (MCL), for TOTAL HALOACETIC ACIDS. The standard for TOTAL HALOACETIC ACIDS is 0.060 mg/L. The running annual average for TOTAL HALOACETIC ACIDS over the same referenced period was 0.085 mg/L.

What Should I do? THERE IS NOTHING YOU NEED TO DO AT THIS TIME. You do not need to boil your water or take other corrective actions. However if you have specific health concerns, consult your doctor,

What does this mean? This is not an emergency and there is no immediate risk. If it had been you would have been notified immediately. **However, some people who drink water containing haloacetic acids in excess of the MCL over many years may have an increased risk of getting cancer.**

The water plant we operate is capable of reducing these compounds to a level below the required limits and we have instituted increased and more regular system flushing and filter backwashing. We believe these changes will bring the system into compliance within the next few months.
